Ethol Archwilydd Mewnol / Appointment of Internal Auditor

Cyflog a Chostau'r clerc / Clerk Costs & Wages

Codwyd cyflog y clerc 5% i £135.74 y mis am 2025-26 ar gynnig Cyng Gwilym Evans ac eiliwyd gan Cyng Daniel Thomas.

The Clerk's salary was increased by 5% to £135.74 a month for 2025-26 – proposed by Cllr Gwilym Evans and seconded by Cllr Daniel Thomas.

- Yr Hen Cysgodfan Bws - Derbyniwyd cyngor nad yw'r Cyngor Cymuned yn medru gwneud contract swyddogol efo unigolyn, angen cynghori'r unigolion i ffurfio grŵp cymunedol heb elw. Gall swyddfa CAVO ei cynghori.
The Old Bus Shelter – Advice was received that the Community Council cannot enter an official contract with individuals, the individuals need to be advised that they should set up a not for profit community group. The CAVO Office could advise them.

Adroddiad Swyddogol yr Archwiliad Llawn hyd Mawrth 2024 / Full Audit Report to March 2024

Derbyniwyd adroddiad boddhaol yn dilyn yr Archwiliad Llawn a nodwyd nad oedd unrhyw faterion wedi dod i sylw'r Archwilwyr sy'n rhoi achos i boeni, pwyntiau wedi'u rhestru isod:

A satisfactory report was received following a Full Audit Inspection and it was noted that the matters that had been noted by the Auditors were not serious, points are listed below:

- Gwefan y Cyngor Cymuned ddim wedi'u diweddarau.
The Community Council website needs to be updated.
- Angen diweddarau copi o'r Model Reolau Sefydlog 2025 (Cymru).
Model Standing Orders 2025 (Wales) copy needs updating.
- Gwall teipio esboniadol wedi'u drosglwyddo o ffigyrau 2022-23 draw i ffigyrau 2023-24
An explainable typo had been transferred from 2022-23 figures to 2023-24 figures.
- Nid oedd angen cofrestru efo HMRC ar gyfer gwneud cyflogau ar gyfer un gweithiwr ond trafodwyd hyn a chytunwyd ar gyngor y Clerc byddai'n mwy addas i gofrestru efo HMRC gan mae'r Clerc oedd yn prosesu'r cyflogau.
There is no need to register with HMRC if only employing one person, but this was discussed and on the advice of the Clerk it was agreed that it would be more appropriate to register with HMRC as it was the Clerk who processed the salaries.

The Internal Auditor needs to approve and sign the accounts prior to the AGM

Cyngor Sir Ceredigion County Council

Trafodwyd a gofynnwyd i'r clerc gysylltu efo'r Cyngorydd Sir i wybod beth yw maint cyfreithiol ar godi sied cyn bod angen caniatâd cynllunio.

Following a discussion, it was agreed that the Clerk contact the County Councillor seeking clarification regarding the size of sheds that can be erected without planning permission.

Toiledau Cyhoeddus Llangeitho

Cytunwyd nid yw'r Cyngor Cymuned, ar hyn o bryd, mewn unrhyw sefyllfa i gymryd drosodd y cyfleusterau cyhoeddus yn Llangeitho a phwysleisiwyd faint mor bwysig ydynt at ddefnydd y cyhoedd â'r gymuned.

It was agreed that the Community Council are, at present, in no position to take over the running of the public conveniences in Llangeitho and it was emphasised how important the facilities were for the use of the public and community.

One Voice Wales Conference to be held on the 1st October 2025, proposals to be submitted by 20th September.

An e-mail was received from Llewod Llambod/Lampeter Lionesses requesting support to keep the Sports Hall at the University in Lampeter open for the use of the club. It was agreed to write a letter of support.

Unrhyw Fater Arall/Any Other Business

- Soniwyd bod yr arolwg blynnyddol yn mynd i'w chynnal ar y parc yn ystod mis Mehefin. Cyng Beryl Evans wedi cynnig glanhau'r eitemau cyn yr arolwg ac i gadw llygad allan ar yr eitemau.
It was noted that the annual inspection of the play area in the park would be held in June. Cllr Beryl Evans volunteered to clean the equipment prior to the inspection and to keep an eye on the items.
