**Cofnodion y cyfarfod diwethaf/Minutes of the last meeting**

Derbyniwyd cofnodion y cyfarfod diwethaf ar gynnig Cyng John Evans ac eiliwyd gan Cyng Gwilym Evans.  
*Cllr John Evans proposed accepting the Minutes of the last meeting, and this was seconded by Cllr Gwilym Evans.*

**Materion yn codi o'r cofnodion/Matters arising from the Minutes**

- Trefniadau ar gyfer rhoi byffer rwber newydd ar glwyd y parc ar y gweill.
- *Arrangements to put a rubber buffer on the park gate are in place.*
- Soniwyd fod y biben drain rhwng Henbant a Cilcert angen ei adnewyddu.
- *The drain pipe between Henbant and Cilcert needs replacing.*
- Derbyniwyd cadarnhad fod cwmni aswiriant Zurich yn fodlon ychwanegu'r milwr ar gylchfan Llangeitho yn rhad ac am ddim ar bolisi aswiriant y Cyngor Cymuned am eleni. Amcan bris gwerth y milwr a dyfynnwyd i'r cwmni aswiriant oedd rhwng £18,000-£20,000. Trafodwyd a chytunwyd i'r Clerc gysylltu. Cyng Daniel Thomas wedi trosglwyddo enw cyswllt am grant oddi wrth Cadw i'r Clerc. Clerc i ymchwilio ymhellach.
- *Zurich Insurance Company confirmed that it was willing to add the war memorial near Llangeitho roundabout to the Community Council's insurance policy at no extra cost this year. The estimated valuation of the war memorial given to the insurance company was £18,000-£20,000. This was discussed and the clerk was to get in touch with the insurance company. Cllr Daniel Thomas has passed on a contact name at CADW for a grant application to the clerk. Clerk to make further enquiries.*

- *A new estimate has been received from Henry Bulman for white plastic fascia boards: £300 + VAT. The work was discussed and it was agreed that the necessary work should go ahead.*
- Derbyniwyd e-bost oddi wrth Matt Redmond, Dirprwy Brif Weithredwr, Comisiwn Ffiniau a Democratiaeth leol Cymru yn cadarnhau bydd y Comisiwn yn cyhoeddi cynigion drafft dechrau 2018 lle bydd ymgynghoriad arall am 12 wythnos.
- *An email was received from Matt Redmond, Deputy Chief Executive, Boundaries' Commission and Wales Local Democracy, confirming that the Commission will publish draft proposals at the start of 2018 when there will be a further 12-week consultation period.*
- Derbyniwyd adroddiad ar lafar oddi wrth Cyng Daniel Thomas a oedd yn Datgan Diddordeb ynghyd â Cyng Gwenfair Owen a oedd hefyd ar is-bwyllgor y Neuadd Jiwibili.
- *A verbal report was received from Cllr Daniel Thomas (who was declaring an interest) and Cllr Gwenfair Owen (who was also declaring an interest) and was also on a sub-committee of Jubilee Hall.*
- E-bost wedi'u dderbyn oddi wrth Eifion Jones, Swyddog Llwybrau Cyhoeddus, Cyngor Sir Ceredigion yn egluro am sefyllfa lôn Penforial sydd yn lwybr cyhoeddus yn rhedeg ar yr un trywydd a hawl preifat sydd yn arwain at dai a ffermdai. Dyletswydd i gynnal a chadw'r hawl cyhoeddus sydd gan y Cyngor Sir ac nid dyletswydd i gynnal a chadw'r hawl breifat. Soniwyd bod safon y llwybr cyhoeddus er bod yna dyllau yn wyneb yr heol mewn manau, mae'r safon dipyn yn uwch nag y byddai ar rannau helaeth o'r rhwydwaith ac yn fwy na boddhaol i'r defnydd cyhoeddus.
- *Email received from Eifion Jones, Public Footpaths' Officer, Ceredigion County Council, explaining the situation about Penforial lane which has a public footpath running along its private road which leads to several houses and farms. The County Council has the obligation to maintain the public right of way, not the obligation to maintain a private right. It was noted that the standard of the public footpath, although there were holes in the surface of the road in places, was a lot better than it was on much of the road systems, and more than satisfactory for public use.*
