Cofnodion y cyfarfod diwethaf/Minutes of previous meeting

Derbyniwyd cofnodion y cyfarfod diwethaf ar gynnig Cyng John Evans ac eiliwyd gan Cyng Emyr Jones.
Cllr John Evans proposed accepting the Minutes of the last meeting, and this was seconded by Cllr Emyr Jones.

- Clerc yn disgwyl tudalennau cyfrifon y Cyngor nôl oddi wrth Dechnoleg Taliesin ar gyfer llwytho ar wefan y Cyngor Cymuned.
- *Clerk awaiting accounts pages to be returned from Technoleg Taliesin so that they can be uploaded onto the Community Council's website.*
- Soniwyd bod y gwaith ar fin cael ei wneud ar culvert oedd wedi rhoi fewn ar yr ochr dde wrth droi lan o Parcrhydderch, Llangeitho, SY25 6QG lan am Bronaeron, Llangeitho, SY25 6QQ.
- *It was noted that work was about to commence on the collapsed culvert on the right hand side as you turn up from Parcrhydderch, Llangeitho, SY25 6QG towards Bronaeron, Llangeitho, SY25 6QQ.*
- Nid oedd perchennog y darn tir oedd Mr Gareth Davies, Parcrhydderch wedi rhoi i'r Cyngor Sir Ceredigion yn amlwg. Soniwyd bod Mr Brian Thomas yn mynd oddi amgylch efo Cyng Rhodri Evans yn fuan a gawn drafod y mater yma yn y fan a'r lle.
- *The piece of land that Mr Gareth Davies, Parcrhydderch, had given Ceredigion County Council was not obvious. It was noted that Mr Brian Thomas would be accompanying Cllr Rhodri Evans locally in the near future and that they would discuss it at the location.*
- Angen torri coed sy'n tyfu allan wrth ddod fyny rhiw Pontgoy, Cyng Emyr Jones i wneud ymchwil.
- *Need to cut trees back on Pontgoy hill; Cllr Emyr Jones to do some enquiries about this.*
- Trafodwyd y cais grant i lanhau'r milwr ar y cylchfan a derbyniwyd cadarnhad bod Mr Kieran Elliott yn medru cario allan y gwaith yn y Gwanwyn. Gofynnir i'r Clerc gysylltu â Julie Osmond, Cadw i weld a fyddai ail-leoli'r railings gwreiddiol yn medru cael ei rhoi o dan yr un cais am grant a glanhau'r milwr. Pe bae'r railings yn medru cael ei chynnwys gofynnir i'r Clerc gysylltu â Ray Burrell, Cwmmagwr ac Alex Paige, Llanbedr PS. Gellir gofyn i James Memorials, Llandre am amcanbris arall i ddod allan i'w lanhau os bydd angen.
- *The grant application to clean the soldier monument on Llangeitho roundabout was discussed and it was confirmed that Mr Kieran Elliott could do the work in the spring. The Clerk was asked to contact Julie Osmond, from CADW, to see if placing railings once more around the monument could be added to the grant application for cleaning the monument. If placing the railings can be done again, the Clerk is asked to contact Ray Burrell, Cwmmagwr and Alex Paige, Lampeter. It is also possible to ask James Memorials, Llandre, for another quote to come out and clean, if necessary.*
- Cyng Rhodri Evans dal yn disgwyl i Mr Dafydd Wyn Morgans ddychwelyd iddo ar sefyllfa'r byrddau gwybodaeth oddi amgylch pentref Llangeitho, gan fod arian Ewropeaidd a ddefnyddir i brynu'r byrddau yn y lle cyntaf.
- *Cllr Rhodri Evans is still waiting for Mr Dafydd Wyn Morgans to respond about the situation regarding the information boards dotted around Llangeitho, as European money was used to purchase the boards initially.*
- Cyng Rhodri Evans wedi siarad â'r Cyngor Sir Ceredigion am y diffyg casglu sbwriel ar amser.

- *Cllr Rhodri Evans has spoken to Ceredigion County Council with regard to rubbish collections not being on time.*
- *Soniwyd bod adroddiad yr Heddlu i'w symud i ddechrau'r agenda yn y cyfarfodydd misol o hyn allan.*
- *It was noted that the Police report would be moved to the start of the Community Council's monthly meeting agenda in future.*
